Health in All Policies approach concerns public policies and how policies in other sectors influence health and wellbeing and social determinants of health. The purpose of this webinar is to address especially economic and social inequalities-related factors in Nordic countries and Scotland, in times of COVID-19. Our aim is to gather experts to address the challenges COVID-19 has brought up regarding health, social protection and the economy.
